# **Annual Report of the Pastoral Charge Supervisor**

Over the past year it has, again, been my privilege to serve as the Pastoral Charge Supervisor for Westminster United, Medicine Hat. I have attended the annual meeting this past spring, been present (by zoom) at Board Meetings monthly, and shared in several conversations about the life and work being done, and the future directions for God's people in this place. It has been a busy year.

I want to thank Anna-Marie Hancock for her capable work as Chair, and all the members of the Board for their willingness to engage in some challenging discussions and decisions. Their leadership will empower Westminster into its future.

Since my first board meeting at my first church (as a student minister) in September, 1965 I have seen the church quite frequently go through many changes and face significant challenges. This past year has been no different. In addition to the ongoing work of tending to the building, property, and people of Westminster, several significant challenges have been engaged. We need to update the names of the Trustees on the titles of the property of the church and manse, clarify the relationship with Little Owl Daycare and negotiate a new lease, and to begin discussions (with support from the Chinook Winds Regional staff) as to the future direction and life this congregation will embrace. That's quite a load!

We live in a much different world than the one I encountered as a student minister. So many changes in technology, the make-up of our culture, our economy, and even a pandemic, have caused us to know that what once was comforting and comfortable will no longer meet the needs of our world. Such transitions are not easy. Yet they lie before us, and we need to wisely listen for the leading of the Holy Spirit as we are called into new ways of ministry for these emerging days.

During this coming year, there will be lots more discussion and many challenging decisions. The work of God through The United Church of Canada in southeastern Alberta is growing and changing. As we engage in the discussions, dreaming, planning and enacting of those new patterns of ministry we remember: "We are not alone. We live in God's world."

We want to encourage our congregants to take a more active role in the operations of the church. This can easily be attained by joining one of our many committees. The chairperson of each committee fills the spot on the Board; other committee members are able to help with a variety of activities that the committee wants to undertake. #### **BOARD OF TRUSTEES**

The Board of Trustees holds the Westminster United Church property in Medicine Hat in trust for the United Church of Canada.

The trustees for 2023 were Pat Evans (Chair), Sharon Clay, BJ Maddaford and Rev. Bob Wallace, Pastoral Charge Supervisor. Trustee responsibilities include investments and insurance. Our investments are held through the United Church Foundation and are held in a fund which follows the Foundation's ethical and performance objectives. The market value of our investments as of December 31, 2023, was \$34,396.12. We withdrew \$17,500 from our investments in 2023 to cover the cost of replacing the manse roof and our operating deficit.

We transitioned to the new in-house insurance program developed by the United Church of Canada in June, 2023. The new in-house program is intended to reduce insurance premiums but provide the same coverage as the previous program. The UCC Protect program provides comprehensive property and liability insurance as well as crime, equipment breakdown, abuse coverage and Directors' and Officers' liability coverage. The insurance premium for 2023 was \$9,616.25 compared to \$12,061.65 for 2022. The church is insured for \$4,690,865.00 and the former manse is insured for \$394,693.00.

The former manse continued to be rented to Ali and Hakima Al Mansour.

In 2023, Little Owl Learning Centre continued to rent a substantial portion of the lower level of the church and have done considerable upgrades including to their playground area. With the assistance of Joel Den Haan from the Chinook Winds Region productive negotiations were held with Little Owl regarding renewal of their lease. I would also like to acknowledge the assistance of Linda Kisell for all the help she has provided in working with Little Owl Learning Centre. Little Owl children presented a Christmas concert in our sanctuary on December 22<sup>nd</sup> to a large group of family members.

Pat Evans and BJ Maddaford attended an informative online Trustee webinar in March, 2023 which provided information about trustee roles and responsibilities.

We have been working to update our property titles with the assistance of Chinook Winds Region.

#### PROPERTY COMMITTEE REPORT FOR 2023 ANNUAL REPORT

The owners of Little Owl Learning Centre have done leasehold improvements at their expense, including many renovations and upgrades to the areas that they are renting. During 2023 they began renting the Dot Wilkinson room. The also upgraded the playground area, which looks great! The Girl Guides continued to meet at the church on Tuesdays and Wednesday evenings and now meet in Memorial Hall and the former nursery. One support group is meeting at the church on Thursdays in the former nursery. We also have a small group of line dancers who practice in Memorial Hall regularly and PEO which meets once a month.

We continued regular required maintenance activities and repairs. This included cleaning the eave troughs, tree trimming of the large pine tree on the north side of the church and the spruce trees at the manse. The manse roof was replaced in April, 2023. Lawn maintenance and snow removal was handled by Crock's Lawn and Snow. Required inspections of the alarm system, fire extinguishers, boiler, backflow preventers, kitchen fire suppression system, and wheelchair lift were conducted.

We were advised to upgrade the expansion tank on the boiler which will be done in early January, 2024.

Utility costs have risen sharply over the last couple of years, however we did receive a rebate on our electricity costs.

Special thanks to our secretary/custodian Jennifer Johnson for all manner of assistance in dealing with building users and looking after the church on a day-to-day basis. We also extend our thanks to everyone who helped out with property matters in 2023.

We appreciate the time and effort of the staff to ensure the positive ongoing activities in the church. As chair I appreciate the support and wisdom of Linda Kisell. Thanks so much to all for a successful year.

# **Christian Development Committee**

The Christian Development Committee (CD) consists of one member, myself. Conventionally, it is the committee at the Board of Elders charged with overseeing Christian Development activities for the congregation of Westminster United Church. This oversight could/would include the Sunday School, the Nursery, Bible Study(ies), Youth Group, as well as supporting CD activities beyond our congregation, such as St. Andrews' and St. Stephens' Theological Colleges, and Chaplaincy programs such as the Medicine Hat Ecumenical Chaplaincy Program at the Medicine Hat Community College.

We did not have a Sunday School, Nursery, or Youth Group in 2023, for the lack of a "need" of them. There is an Adult Bible Study Group that meets on a weekly basis, at Chinook Seniors Living Complex with Rev. Dave Pollard from our sister congregation at Fifth Avenue Memorial leading the group.

Due to fiscal challenges, we have elected to not send financial support as a congregation to St. Andrews' and St. Stephen's Theological Colleges. We did send our budgeted pledge to the Medicine Hat Ecumenical Chaplaincy Program, albeit a greatly diminished amount. If individual members of the congregation wish to contribute to these, they are most certainly invited to do so.

In October, a monthly "sock" drive was started for donations of socks, with each month's "basket" being delivered to a local community organization dedicated to helping the less fortunate. In November, I took the first basket of socks to the Salvation Army Community Resource Center, in December, the delivery was to the Root Celler, and it is hoped that future community recipients will include the Women's Shelter, the Homeless Shelter and other organizations in our community.

We also collect donations of non-perishable food items and personal hygiene products for the "Pantry" at the Medicine Hat Ecumenical Chaplaincy. These are picked up on a monthly basis by a volunteer from the Board of Directors of the Medicine Hat Ecumenical Chaplaincy Program.

I continue to be the representative from Westminster United Church on the Board of Directors of the Medicine Hat Ecumenical Chaplaincy Program. This group meets once a month, and receives a monthly report from Pastor George Koopman.

The "Knitting Circle" meets once a week for knitters and crocheters to get together, "ply their craft" and enjoy each other's company. Anyone who wants to spend a Tuesday afternoon socializing is welcome. There is no cost to join. Just bring your needle(s) and yarn. Donations of yarn are always welcome! This Fall, donations of toques and scarves, made by our knitters, were delivered to the Root Cellar and the Women's Shelter. Prayer Shawls already on hand are being distributed to congregational members by the Pastoral Care Committee.

Thursday afternoons, we have "coffee hour" for anyone wishing to enjoy a "cup of Joe" and socialize with others. Noon hour luncheons were also hosted on an irregular schedule to provide an opportunity to enjoy some "breaking of bread" time with others. Many thanks to those who help host these gatherings. It is true that "many hands make light work".
